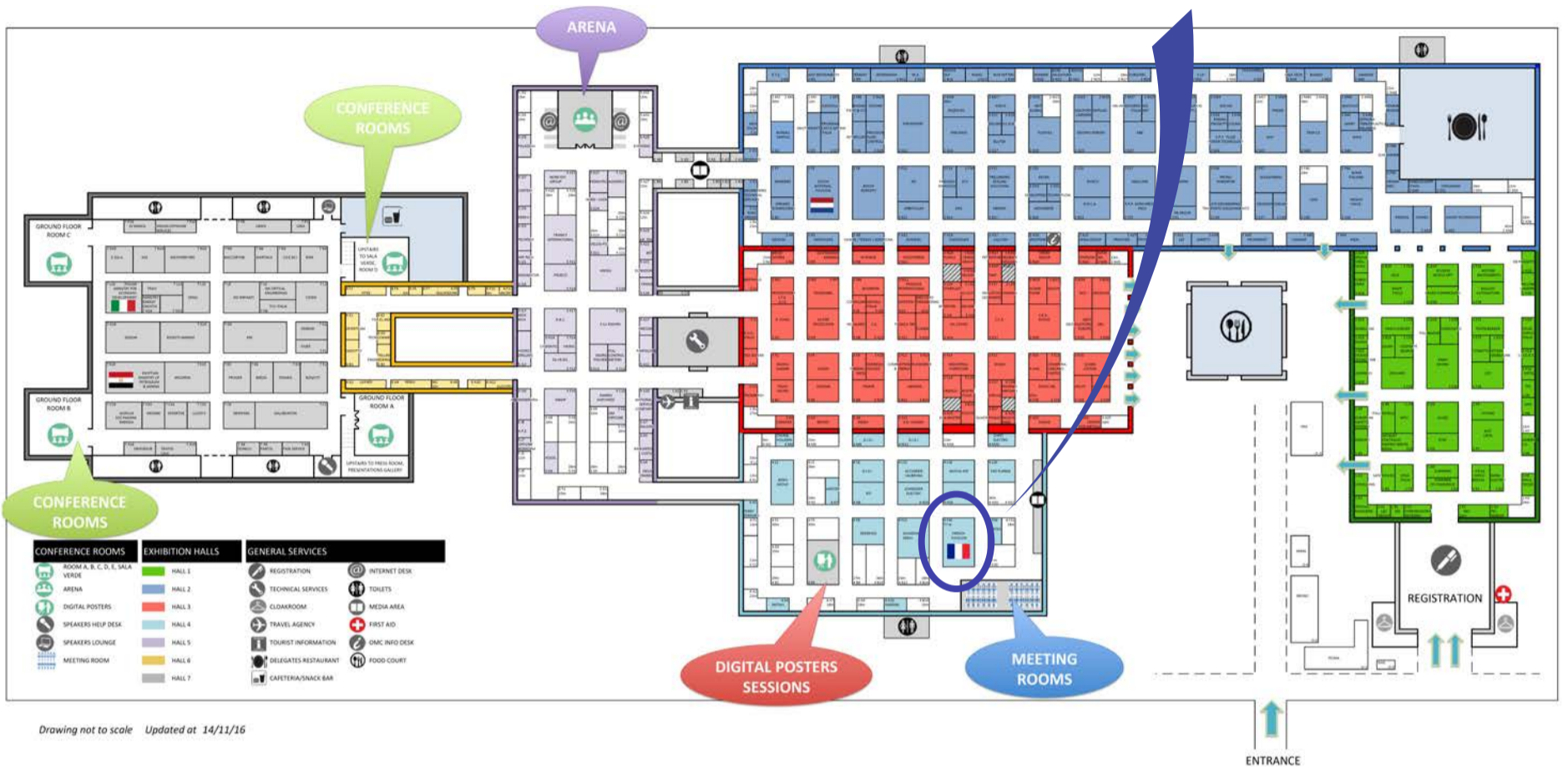

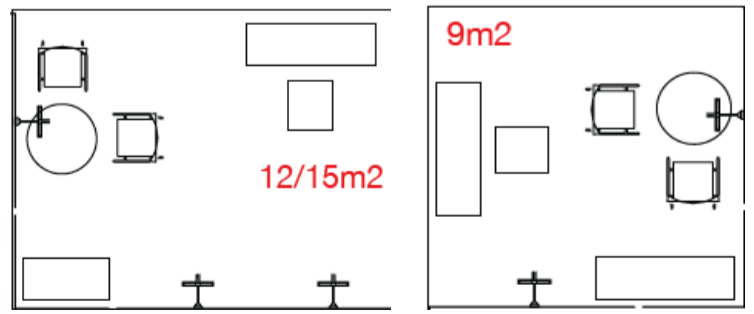

IES will refund the 50% deposit payment, after the deduction of the registration fee, if the cancellation is received before 31 October 2016. The registration fee will not be refunded in any case and will be considered as penalty of the cancellation.

No refund is due for cancellations received after 31 October 2016.

PAYMENT SCHEDULE & PROCEDURE

50% advance payment is due at booking, a copy of the bank transfer is due with the exhibition space application. 50% balance is due by 31 October 2016. For bookings after 31 October 2016, 100% payment is required at time of booking.

By signing this contract we understand that we are entering into a legally binding contract. We apply for exhibition space at OMC 2017 and we agree on the contract's terms including the conditions printed on the reverse of this form which we have read and we accept.

1. **OMC 2017 - Offshore Mediterranean Conference & Exhibition** will take place in Ravenna, Italy, from 29th to 31st March 2017.

2. **ORGANISERS** - OMC 2017 is co-organised by IES Srl and OMC Scrl, here in after named the Organisers.

3. **ADMISSION TO THE EXHIBITION** - The following categories are admitted as Exhibitors: a) Companies, Associations and Organisations which are exhibiting their products or services in the various sectors provided for at the Exhibition, including their concessionaires, agents or representatives. The Organisers reserve the right to admit to the Exhibition companies, associations and organisations not covered by the preceding paragraph; to exclude from the Exhibition certain services, products or samples; and to prohibit the presentation of products, samples or services by a single company in more than one stand in a single exhibiting sector. Children under the age of 16 are not admitted to visit the exhibition.

4. **ACCEPTANCE OF / MODIFICATIONS TO THE EXHIBITION REGULATIONS** - By signing the application to take part, the Exhibitor agrees to accept the general regulations and approves the stand assigned to the Exhibitor. Any integrating rules and provisions of a general or technical nature, as set out in the Technical Regulations of the Exhibitor's Manual, which form an integral part of the present general regulations, are taken as accepted by the signing of the application to take part.

5. **FEES, PAYMENTS, RESOLUTORY CLAUSE** - Participation fees and registration fee are indicated in the Space Contract. On receiving the Space Contract the Organisers will issue an invoice for the sum specified in the space contract. The issue of an invoice does not bind the Organisers to accept any application for participation. Should an application not be accepted the above-mentioned sum will be returned without any payment of interest. If an application is accepted the Organisers will give formal written notice to the applicant. The payment must then reach the Organiser, or its representatives, within the period indicated on the invoice: should this not occur the contract may be considered null and void without the need to serve notice to the applicant or to obtain a judicial ruling but simply by communicating the fact. In this case the Organisers is released from all contractual obligations and may assign the exhibiting space to other applicants. The Organisers also have the right to retain any sums already received and are legally entitled to any outstanding contractual payments. The Organiser's right to any further damage compensation payment remains unaffected.

6. **REGISTRATION FEE** - Each exhibiting company is required to pay a registration fee of € 450,00 plus IVA/VAT covering administrative registration and its listing in the exhibition catalogue. By signing the Space Application Contract, the Exhibitors agree to specify the company names and relevant information on all those companies and brands or represented partners. A sum of € 450.00 plus IVA/VAT will be paid for each party exhibiting as registration fee for publication in the official catalogue of the exhibition.

7. **CONFIRMATION OF ADMISSION** - The Organiser, or its representatives, will issue written acceptance of the application with official notice of confirmation. This is valid only for the Exhibitor to whom it is addressed. The total or partial transfer of the assigned stand is prohibited, even when free of charge. If this condition is not adhered to, the goods displayed may be removed at the expense of the Exhibitor. Those responsible for unauthorised transfer of the stand will also be subject to a fine equivalent to the total space contract fee.

9. **ISSUE OF STANDS** - The distribution of the stands will be decided by the Organisers in accordance with the general interests of the exhibition. The Exhibitor accepts the right of the Organisers to alter the positions and setting up of the stands, to change the layout or reduce the dimensions at any time prior to the opening of the exhibition, while taking into account the right of the Exhibitor to be duly informed within 30 days prior to the opening date in order to adapt to the modifications.

10. **PROVISION OF STANDS** - Shell and turnkey stands will be made available to the Exhibitors at 8.00 of the second day before the opening. Space only stands are not provided with the electrical connection which can be ordered separately by the Exhibitor. Space only stands include space, aisle cleaning and general pavilion security. All stands must be fully set up by 18.00 of the second day before the opening. Should this not occur, the Organisers may apply a cost for overtime working. The Organiser have the right to modify the duration of the Exhibition or the opening and closing times thereof. Exhibitors shall not be entitled to any claim or compensation in connection with such modifications.

11. **RETURN OF STANDS** - At the end of the exhibition, and not before, the Exhibitors must remove their products and materials and leave the exhibition premises. The stands must be cleared away by 19.00 on the second day after the closure of the Exhibition. The Exhibitors expressly authorise the Organisers to check that, on leaving the exhibition premises, there are no products or materials in the vehicles or luggage of the Exhibitors and/or their associates, which are different from those that were installed in their stand. The Organisers cannot be held in any way responsible for goods, materials or anything else left by the Exhibitors on the exhibition premises without supervision. Should any stand not be cleared away within the period stipulated above, the Exhibitor responsible will be legally obliged to reimburse the Organisers for removal and/or clearing away and storage expenses. After 30 days following the closure of the exhibition, the Organisers may proceed with the selling of any uncollected objects or materials by whatever procedure they consider to be most suitable. The net proceeds, after the payment of any outstanding debts owed to the Organisers will be credited to the Exhibitor.

12. **INSURANCE** - Each Exhibitor exhibits at its own risk. The Exhibitor is responsible for and shall indemnify IES S.r.l. (the Organiser) in respect of all claims (whether arising from personal injury or damage to property or otherwise), arising in connection with the erection and dismantling of the Exhibitor's stand and anything permitted, omitted or done thereon or therefrom during the period of the exhibition or during the construction and dismantling periods arising directly or indirectly by the act, omission or neglect of activity or other article or thing of the Exhibitor or in the possession or use of the Exhibitor. The Organisers will take such precautions as they may consider appropriate for the proper running of the exhibition, but will not at any time be responsible for the loss, or damage to, or safety of any stand, exhibit, materials or other property of an Exhibitor or any other person under any circumstances. All Exhibitors are advised to effect their own insurance against all relevant risk. In any event, such Exhibitors must hold a Public Liability policy of insurance for negligence providing cover of at least € 4.000.000,00 injury or damage.

13. **SURVEILLANCE AGAINST THEFT - RESPONSIBILITY FOR THEFT AND DAMAGE** - During the exhibition opening hours the Exhibitors must keep watch over their stand, either directly

or through their associates. The Organisers, while providing a general day and night surveillance service inside the Exhibition Premises for the full duration of the Exhibition, are exempt from all responsibility for any theft or damage which might occur to the detriment of the Exhibitors. The Exhibitors will also be responsible towards the Organisers for any damage, either direct or indirect, which, by whatever cause, is attributable either to them or to personnel acting on their behalf (including damage caused by fittings or equipment set up either by themselves or by third parties, even if previously inspected by the Organisers). The Exhibitor should return the stands in the condition in which they were issued. When specific claims are made by the Exhibitor, the Organisers will restore the stands to their original condition at the Exhibitor's expense.

14. **UNFORESEEN CIRCUMSTANCES, FORCE MAJEURE** - None of the Organisers, its subsidiaries, employees, agents, or the Organisers and its Connected Persons shall be liable for loss, damage or delay resulting from acts of war, civil commotion, strikes or lockouts, shortage of labour, default or failure of suppliers, government action, law or regulation, military activity, fire, flood or any other circumstances beyond the Organisers' reasonable control which shall make it impossible or inadvisable for the Exhibition to be held at the time and place provided, and the Organisers reserve the right to re-schedule the Exhibition at another date and/or at any alternative site. The Exhibitors acknowledge that the Organisers have sustained damages and losses as a result of such circumstances beyond reasonable control or in any case beyond the control of the Organisers, therefore should the exhibition not be held for these reasons, the fees paid by the Exhibitors will remain the property of the Organisers.

15. **PHOTOGRAPHS AND DRAWINGS** - The Exhibitors may not take photographs or make drawings inside the pavilions unless specifically authorised to do so by the Organisers. The Organisers only may take photographs outside any stand and use them without the obligation to make any recompense.

16. **EXCLUSION OF LIABILITY** - The Exhibitor accepts all risks associated with the use of the exhibit space and environs. The Exhibitor shall not make any claim or demand or take any legal action, whatsoever, against the Organisers, the show sponsors or the facility in which the Exhibition is held, for any loss, damage, or injury whatsoever caused to the Exhibitor, its officers, employees, agents, or their property.

17. **INDEMNITY** - The Exhibitor hereby indemnifies the Organizers, the show sponsors and the facility, their respective officers, agents and employees, against all claims, costs, and charges of every kind resulting from their occupancy of the exhibit space or its environs, for personal injuries, death, property damages sustained by the Exhibitor or its officers, agents or employees or those for whom in law they are responsible, or the Organizers or a visitor to the show.

18. **ADVERTISING** - The distribution of materials illustrating the products on display is permitted only within the stands. No posters may be displayed outside the stands. Any other type of advertising outside the stands is forbidden, including the distribution of materials in the corridors, in the streets of the Exhibition area and in the immediate neighbourhood. The display and distribution of all graphic materials - written notices, signboards, posters, brochures, leaflets, hand-outs, maps, plans, etc. - not strictly linked to the Exhibition or whose contents may directly or indirectly be interpreted as a criticism or offence to other countries is forbidden. Advertising - with the exception of that displayed within the individual stands - may be carried out by means of the Organisers in all permitted forms and provided their written agreement. Failure to adhere to the provisions set out above will give the Organisers the right to exclude those responsible from the exhibition. The contents of this article also apply to third parties who intend to carry out advertising or promotional operations of any kind within the Exhibition area. The display of prices and sale of products are forbidden, with their immediate removal.

19. **TECHNICAL AND EXECUTIVE PROVISIONS** - As well as the application to take part, the Organisers will send to the Exhibitors the Exhibition Manual, containing the Technical Regulations, a series of rules as well as order forms for Exhibition services, which should be strictly adhered to by the Exhibitor and its staff, and/or those operating on his behalf, particularly concerning: method and timetable of entrance, timetable of on site works, entry permits, release of authorisations for stand construction, tickets and other promotional materials, the use of technical services, the organisational and logistical operations during the setting up and dismantling stages and the Exhibition period. The Exhibition is held in temporary structures, therefore specific limits of heights and weight must be respected: any stand, construction or structure higher than 2,5 mt can be built only after receiving written approval from the Organisers; the maximum weight permitted in all pavilions and connection tunnels is 500kg/sqm inclusive of stand structures, exhibits and personnel. The Technical Regulations are included in the Exhibitors' Manuals that will be provided to Exhibitors in November 2016.

20. **SPECIFIC WITHDRAWAL CLAUSE** - The Organisers reserve the right to withdraw from the participation agreement with immediate effect, by means of simple written notification to be sent to the Exhibitor should he/she fail to adhere to any of the obligations set out in the General Regulations of OMC 2017.

21. **ARBITRATION CLAUSE** - Any disputes arising between the contracting parties due to interpretation, validity, execution and/or enforcement of this agreement will be exclusively resolved in accordance with the Rules of Conciliation and Arbitration of the International Chamber of Commerce.
